Once a trust has been established, we work on identity, financial stability, skills, and how to give back. Once our youth have gotten to a place where they are moving forward, we begin to expand their circles by introducing a volunteer or Community Coach that allows them to connect better with their community, grow their friend base and begin giving back.
